ABOUT COMPMAG

CompMag was founded in 2017 in response to the California state laws regarding firearms. Recently the laws changed in California. SB 880 and AB1135 passed. This put Californian gun owners in a terrible spot as they would now own "assault weapons". We would have to either register our firearms as "assault weapons" or modify them.

There were a few solutions out there, but they were very model specific, and many required modification to your firearm or breaking your action to reload. We set out to find a solution that could work across many different types and styles of "assault weapons" and would still allow for the normal operation of your firearm.

MADE IN THE U.S.A.

Every CompMag is entirely made in California, U.S.A.. We do this to ensure quality of our products and to support American workers and businesses. Our shop is located in Valencia, California. Here we assemble and ship every CompMag produced since 2017.



The one thing in common with most of these firearms that would make them "California compliant" was to give them a fixed magazine. We went to work...

Countless designs were made, multiple patents were applied for, our lawyers were consulted, manufacturers were interviewed, and finally, in late 2017, our first product came out. The AR-15 CompMag.

The CompMag is the first of its kind. It's a 10 round, fixed, side loadable magazine, made entirely in California U.S.A.. It can be loaded without removing it from your firearm, resulting in a fixed magazine solution that is easy to use. It is designed to last, and it is made with the best materials available. We are very proud of our first CompMag and since then have released an AK-47 version.

CompMag currently has four patents pending for our designs and we are constantly striving to innovate and come out with new models. We are currently working on an AR-10 .308 CompMag and hope to release it in Spring 2018.

David Maga founded CompMag LLC. in early 2017. Before starting he was the Foreman at Studio Art & Technology for 17 years. Studio Art is a high end, movie prop manufacturing company and he was in charge of 20-30 people at any given time.

During this time he amassed a great deal of knowledge about firearms, as modifying firearms for motion pictures was part of his responsibility. At this time he held and maintained many D.O.J. Dangerous Weapons Permits including: Machine Gun permit, Destructive Devices Permit, Short Barreled Rifle Permit, and Assault Weapon / .50 BMG permit.

David is an avid shooter, gun enthusiast, and no stranger to hard work. While he believes the laws and regulations placed upon law-abiding Californian gun owners are ill-conceived, he also believes in helping people become California compliant to avoid prosecution from these laws. ADVANTAGES OF THE COMPMAG.

The CompMag allows you to keep your features you love on your rifle. (pistol grip, forward grip, retractable stock, and flash hider).

- No need to "break your action" or deviate from the normal operation of your firearm to reload.

- No pins to pull out. No fumbling with extra parts or loaders.

- Loads easier than a standard magazine. No heavy spring to push each round against.

- Will fully load on a closed or open bolt.

- One screw installation. The screw threads into a metal insert that is molded into the magazine. No holes to drill. No need to modify your firearm.

- Two minutes to install. Two minutes to remove, should you decide to shoot outside of California.

- Constructed of impact and crush resistant, G.F. Nylon 6.

- Ultra durable and heavy duty, built to last. 150% to 300% thicker side walls than most polymer magazines.

- 17-7 Stainless steel magazine spring.

- Round counter indicates exactly how many rounds are left in your firearm, including what's in your chamber.

- Allows for easy clearing of type 3 malfunctions (such as double feeds).



FREQUENTLY ASKED QUESTIONS

How does the CompMag work?

The CompMag is the ultimate fixed magazine solution for your firearm. Even though the magazine is fixed into the lower receiver, it still allows your firearm to be very easy to use. The CompMag can be loaded through a door in the side while still in your firearm. Loading is easier than with a standard magazine and there is no need to modify your firearm. The CompMag has an internal locking mechanism that locks into your firearm with just one screw. No holes to drill. Installation is very simple. It can also be easily removed by opening the action and loosening the screw from the inside. This allows you to have your fully functional firearm back. This is useful if you are going out of state to shoot or you live in a state other than California. While in California, keep it screwed in at all times to be compliant.

Having a fixed magazine allows you to retain all the other features that we love: a pistol grip, a retractable stock, a forward grip, a thumbhole stock, and a flash suppressor. The CompMag can also be used in other restrictive states besides California. Check your local and state laws to see if the CompMag is right for you.

Loading the CompMag couldn't be easier. 1. Retract the spring and lock it. 2. Slide the loading door open. 3. Load the cartridges in. 4. Shut the door. 5. Release the spring. You are ready to fire.

Will the AR-15 Compmag work with rounds other than .233/5.56?

The short answer to this is No. The AR-15 CompMag is a single stacked design which will only accommodate .223/5.56 ammunition.

Although this is the case, the AR-15 CompMag will work with .300 ACC ammunition because the diameter of the case is the same as the .233/5.56.

Other versions such as .308 (AR10) will be manufactured in the future, but will not be available until the Spring of 2019. The AR-15 CompMag will not accept 6.5 Gendel, 6.8 SPC, .458 SOCOM, .50 Beowulf, 5.7x28mm, or 7.62x39mm.

Will the AK-47 CompMag fit both a stamped and milled receiver?

Yes it will, but you will need to get an additional locking plate for the milled receiver. They are available on our website.

Where can I buy them and how much do they cost?

The CompMag is always available on our website at compmag.com. They are also available at many California retailers such as Turner's Outdoorsman, Outdoor Sportsman, Evolution Sports, Evike, or Sacramento Armory. In New York at they can be found at retailers such as, Empire State Firearms, Good Guy's Guns, or Interlaken Guns and Ammo. You can even get them in Florida at Right to bear Arms and Supply.

They typically retail for around \$64.99.

Is the CompMag California D.O.J. approved?

As we, and our Attorneys, understand it, this product falls within the laws as written. At this point it has not been endorsed or approved by the California Department of Justice, due to their reluctance to endorse any compliance products. Once contacted, the D.O.J. told us that they could not endorse any compliance products and that we should seek the advice of a qualified firearms attorney.

We then had our firearms attorney, Jason Davis, research the topic of California compliance thoroughly and his professional opinion is that the CompMag would be deemed a fixed magazine in accordance with California Law. Below is a summary letter. The full 10 page report can be supplied upon request.

Mr. Maga,

In our recent meeting, you inquired as to whether a specific firearm configuration would, or would not, qualify as an assault weapon compliant device under California's newly expanded assault weapon scheme. Specifically, you inquired as to whether a semi-automatic rifle configured with a CompMag, LLC product identified as a Fixed Firearms Magazine Loadable via a Hinged Door, and described in **Exhibit A** attached hereto would render the firearm a "Fixed Magazine" firearm pursuant to California codes and regulations.

Upon examination of the California's Assault Weapons Control Act, regulations promulgated by the California Department of Justice, and their prior interpretations of the "assault weapon" laws, it is my opinion that a properly installed CompMag Magazine would be deemed a fixed magazine under California law.

I would like to provide the following caveat – cautionary instructions to consumers and OEM's should be issued informing them that the CompMag should be installed on a firearm before any "assault weapon" features are added to the firearm, and preferably while the upper and lower are completely separated. This prevents the momentary assembly of an "assault weapon" from the time that the magazine is inserted into the firearm to the time that the magazine installation is complete.

Is the CompMag New York S.A.F.E. Act Compliant?

We have received many inquiries as to the AR-15 CompMag being used in New York so I thought I would address this topic. First of all, I am not a firearms attorney and we have not had a N.Y. firearms attorney evaluate this product, so this should not be taken as legal advice, but this is how I see it.

The AR-15 CompMag was designed to be a fixed magazine in accordance with California law. California law states that to have a fixed magazine you must break the action of the firearm to remove the magazine. This is solved for California by screwing the magazine in from inside of the firearm.

New York law is different, in that it states that you cannot have the "capacity to accept a detachable magazine". Therefore just screwing it from the inside is not enough to comply with N.Y. law because the capacity is still there.

I believe that there are ways that you crafty New Yorkers have come up with to "permanently attach" the magazine into your firearm to meet this criteria. One solution I have run across is the "Safe Mod" by All Star Tactical. This inexpensive device disables your mag release.

Once "permanently attached" according to N.Y. law, the CompMag is an ideal loading and unloading solution for your AR-15.

If you are unsure if your particular firearm is compliant or not, I would check with your local N.Y. gun store or firearms attorney as to what needs to be done for your specific compliance.

Will we be coming out with other models in the future, will they fit other firearms?

The AR-15 CompMag is compatible with many firearms that accept a STANAG magazine including the SCAR 16s, CZ BREN, SIG 556, and the Bushmaster ACR. We are currently working on an AR-10 .308 version and will continue to make other calibers and models. We also have a speed loader for the CompMag designed, but right now we are more focused on making more firearms compliant.



SUMMARY

The CompMag is a fixed, side loadable magazine for restrictive states such as California and New York. The CompMag converts your AR-15 or AK-47 into an easily loadable, fixed magazine rifle with just one screw. The CompMag is perfect for companies looking to sell their firearms in restrictive states, or for the individual trying to get compliant with their state laws. No modifications to the firearm need to be made for installation and the CompMag installation is easily reversed. All of our products are proudly made in the U.S.A..
